Schedule of Significant Military
Exercises for the Next Twelve Months

The proposed schedule of significant exercises has been reviewed by the NSC staff and we have no objections to it. However, the following qualifications should be noted:

- -- The following restrictions should apply to SMPO PX-49:
- The ships and aircraft involved, including those of other participating SEATO nations, should at no time approach closer than 100 miles from the southern coast of the People's Republic of China, including Hainan Island. In addition, the SEATO forces should maintain a distance of at least 100 miles away from the Paracel Islands, and at least 50 miles away from Macclesfield Bank and the Spratley Islands, all of which are claimed by the PRC. These stipulations are without prejudice to the US position on the conflicting claims to these islands and atolls.
- All publicity concerning the exercise disseminated by US Government agencies should be confined to a minimum of brief factual press releases and responses to press inquiries; no direct or indirect reference should be made to the PRC in connection with this exercise; and the cooperation of other SEATO participants should be sought in these respects.
- -- FLY-A-WAY FY-74, we understand, was postponed until January 27-February 9, 1974, because of the current debate of the Korean question in the U.N. General Assembly. This exercise should be carefully examined by State and Defense in terms of the possible impact

upon the South-North Korean talks. This precaution should also apply to exercises FOAL EAGLE. FREEDOM TORCH and CAPTIVE LIGHTNING I. State and Defense recommendations for the ROK exercises should be submitted for White House approval at least six weeks prior to the critical date for Presidential cancellation.

- -- FOOD CHAIN V should be subject to the same restrictions that applied to the earlier exercises in this FOOD CHAIN series.
- -- PHIBRAIDEX TTPI/QUICK JAB should be carefully examined by State, Defense and the Office of Micronesian Status Negotiations for its possible impact on our status negotiations with the TTPI.
- -- BLACK HAWK III was discussed separately in my November 19 memorandum to you.
- -- Cancellation of POOPDECK 1-74 was requested in my October 30 memorandum.

Of course, we will wish to review all of the exercises prior to implementation within the context of prevailing conditions.
