THE FOLLOWING MESSAGE WAS PICKED UP FROM DUR CUSTOMER AT 1900 HOURS! MAY 2, 1973

(NO DATE INDICATED) THE CHINESE SIDE HOLDS THAT THE NEW SOVIET DRAFT AGREEMENT ON THE PREVENTION OF NUCLEAR WAR, LIKE THE PREVIOUS SOVIET PROPESALS. STILL AIMS AT ESTABLISHING ITS NUCLEAR HEGEMENY IN THE WORLD. WHILE THE AGREEMENT IS DSTENSIBLY CLAIMED TO BE ON THE PREVENTION OF NUCLEAR WAR, ITS SIGNATORIES WILL IN EFFECT UNDER-TAKE NO CLEAR DBLIGATION TO RENDUNCE THE USE OF NUCLEAR WEAPONS, STILL LESS IS A SINGLE WORD MENTIONED ABOUT THE THOROUGH DESTRUCTION OF SUCH WEAPONS: ON THE CONTRARY, THE SIGNATORIES WILL BE GIVEN THE RIGHT TO INTERVENE IN THE AFFAIRS OF THIRD COUNTRIES AND EVEN IN THE RELATIONS BETWEEN NON-SIGNATORIES UNDER THE PRETEXT OF AVERTING THE RISK OF A NUCLEAR CONFLICT. THIS DEVIDUALY IS AN ATTEMPT TO PRACTISE HEGENDAISM UNDER THE GUISE OF "SOVIET-U.S. COOPERATION" AND TO CARRY DUT NUCLEAR BLACKMAIL AGAINST OTHER COUNTRIES IN THE WORLD UNDER THE GUISE OF PREVENTING NUCLEAR WAR. IT GOES WITHOUT SAYING THAT CHINA IS FIRMLY OPPOSED TO SUCH AN AGREEMENT. THE CHINESE SIDE HAS NOTED THAT THE U.S. SIDE EXPRESSED ITS DISAGREEMENT TO STATING AS ABSOLUTE OBLIGATIONS ELEMENTS WHICH THE U.S. SIDE COULD ONLY CONSIDER AS ULTIMATE OBJECTIVES. AT THIS JUNCTURE, EVEN IF THE UNITED STATES AND THE SOVIET UNION REACH AN AGREEMENT MERELY STATING THEIR ULTIMATE DBUECTIVES, THAT WILL STILL HELP THE SOVIET UNION DECEIVE THE WORLD WITH STOLEN FINERY, SPREAD A FALSE SENSE OF SECURITY AND ADD TO MISGIVINGS OF OTHER COUNTRIES ABOUT THE SOVIET UNION AND THE UNITED STATES. IT IS PRESUMED THAT THE U.S. SIDE UNDERSTANDS THIS.
