HAVE JUST HAD HOUR LONG MEETING WITH DAVID POCKEFELLER

AND VISITING CHASE GROUP. THEY SAW HEGAZI, FAWZI, FAHMY,

MINISTER OF RECONSTRUCTION OSMAN AND HEAD DE SUEZ CANAL AUTON-FILE NSC RELEASE MASHOUR YESTERDAY AND RUCKPEELLER IS SEEING SADAT LATER INSTRUCTIONS APPLY

WE DISCUSSED SEVERAL MATTERS:

A. SUEZ CANAL CITIES RECONSTRUCTION: ROCKEFELLER RECOUNTED THAT IN HIS VARIOUS MEETINGS OF VESTERDAY, DNLY FAHMY HAD BEEN A BIT AGGRESSIVE. HE HAD CHARGED USG HAS NOT YET DONE ANYTHING TO SHOW APPRECIATION FOR WHAT SANAT HAS DONE. SPECIFICALLY, HE SUGGESTED USG SHOULD PROVIDE ASSISTANCE OF SOMEWHAT OVER SEVEN BILLION DOLLARS TO RECONSTRUCT DESTROYED SUEZ CITIES AND CLAIMED HE WAS STILL AWAITING A REPLY TO AN EARLIER PROPOSAL THAT HE HAD ALLEGEDLY MADE TO THAT EFFECT. I TOUR ROCKEFELLER THAT NO SUCH PROPOSAL HAD BEEN MADE TO ME. I RECALLED THAT SOME MONTHS AGD FAHMY, WHEN THRNING DOWN OUR REQUEST TO USE A MILLION EGYPTIAN POUNDS FOR UNEF PURPOSES, HA MORI CO5141649 CHUNTERED WITH THE OFFHAND REMARK WE SHOULD USE FORTY OR FIFTY MILLION OF OUR EGYPTIAN POUNDS FOR SUPZ CANAL CITIES RECONSTRUCTION ON GROUNDS WE WERE INDIRECTLY RESPONSIBLE FIRE THEIR DESTRUCTION. BI TOLD ROCKEFELLER I COULD NOT REGARD THIS AS A SERIOUS PROPOSAL. State Dept. review completed

ROCKEFELLER SUGGESTED THAT IT MIGHT BE USEFUL IF WE CHOSE ONE OR TWO IMPACT PROJECTS SOMEWHERE IN SUEZ CANAL CITIES FOR USG RECONSTRUCTION ASSISTANCE AND SUGGESTED PERHAPS HOSPITALS. I TOLD HIM THAT FROM MY VANTAGE POINT I WAS SYMPATHETIC TO SUCH AN IDEA, BUT I THOUGHT WE SHOULD ALL RECOGNIZE THAT UNTIL SUCH TIME AS OIL EMBARGO IS LIFTED, IT WILL BE EXTREMELY DIFFICULT TO THINK IN TERMS OF ANY LARGE SCALE USG ASSISTANCE

MOREOVER, HAVING IN MIND THE KIND OF COMMENT

FARMY AND OTHERS HAVE MADE OF ALLEGED USG INDIRECT RESPONSIBILITY FOR DESTRUCTION OF SUEZ CANAL CITTES, I HAD PERSONAL DOUBTS ABOUT RECONSTRUCTING MOSPITALS. ECYPTIANS WOULD BE LIKELY TO CAST THIS IN TERMS OF COMPENSATORY HELP. IT WOULD BE BETTER TO THINK OF SOMETHING ELSE. TO DO SO, HOWEVER, WE REALLY HAVE TO KNOW A LITTLE MORE ABOUT JUST WHAT IS GOING TO BE DONE IN SUEZ CANAL CITIES RECONSTRUCTION THAN WE DO NOW. WE ARE NOT YET ABLE TO VISIT THESE AREAS AND IT IS DIFFICULT TO TALK ABOUT ANY PROJECTS OF THAT SORT SIGHT UNSEEN.

POSSIBILITY OF CHASE BANK OPENING HERE: RACKEFELLER TOLD ME THAT IN HIS PREVIOUS MEETING WITH SADAT LAST SEPTEMBER, THE PRESIDENT HAD UNEXPECTEDLY SUGGESTED CHASE OPENING A BRANCH IN CAIRD. HE HAD IN PAST FEW DAYS SOUNDED OUT APPROPRIATE ISRAELI DEFICIALS AS TO THEIR REACTION TO ANY SUCH STEP AND HAD FORMED THEM AGREEABLE. HE INTENDS THEREFORE TO RAISE MATTER AGAIN IN HIS MEETING WITH SADAT TODAY AND ASCERTAIN WHAT PRESIDENT MAYAVE IN MIND IN TERMS OF TIMING. SUCH ACTION MIGHT BE TAKEN IN TWO STAGES: FIRST, ESTABLISHMENT OF A CHASE REPRESENTATIVE HERE, AND SECOND, AT SOME LATER DATE, FORMAL ESTABLISHMENT OF A CHASE BANK IN CAIRD. THE THE AIDES THEN REPORTED THAT HEGAZY HAD INFORMED HIM YESTERDAY THAT, PURSUANT TO SADAT'S INSTRUCTIONS, ARRANGEMENTS WOULD SHORTLY BE MADE FOR CHASE TO ACQUIRE A 49 PERCENT EQUITY INTEREST IN A JOINT CAIRD BANKING VENTURE TO CONSIST OF THE NATIONAL BANK OF FGYPT. KAISSOUNI'S NEW EGYPTIAN INTERNATIONAL BANK, AND CHASE. ROCKEFELLER THOUGHT THIS WAS ACCEPTABLE.

ROCKEFELLER NOTED THAT AT THE APPRORIATE TIME AN ANNOUNCEMENT WOULD HAVE TO BE MADE AND THOUGHT THIS SHOULD BE AS SOON AS POSSIBLE SINCE THE NEWS IS BOUND TO LEAK OUT. I SUGGESTED HE DISCUSS TIMING OF ANY SUCH ANNOUNCEMENT WITH SADAT AND BE GUIDED BY HIS VIEWS. IN ANSWER TO ROCKEFELLER'S SPECIFIC DUESTION: I EXPRESSED MY PERSONAL VIEW THAN AN ANNOUNCEMENT A CHASE REPRESENTATIONS WILL SHORTLY BE ESTABLISHED HERE WILL BE A FURTHER PLUS IN OUR EFFORTS TO STRENGTHEN US-EGYPTIAN RELATIONS.

3. SUMED DISCUSSIONS: ROCKEFELLER ASKED ABOUT CURRENT STATUS OF SUMED TALKS. ONE OF THE MEMBERS OF THE BECHTEL NEGOTIATING TEAM, DORMAN, HAD APPARENTLY BRIEFED A CHASE REPRESENTATIVE A FEW DAYS ACO. CHASE, ROCKEFELLER INDICATED, IS CONSIDERING PROVIDING THE ECYPTIAN SIDE WITH SOME FINANCIAL ASSISTANCE ON THIS PROJECT. SINCE THE CHASE PEOPLE APPEARED TO HAVE THE IMPRESSION (1 SUSPECT FROM HEGAZY RATHER THAN DORMAN) THAT THE PRINCIPAL OUTSTANDING PROBLEMS WERE VIRTUALLY SOLVED, I OUTLINED FOR THE GROUP PRESENT STATE OF PLAY. I POINTED OUT BECHTEL TEAM HAD BEEN TOLD THERE WAS NO ONE AVAILABLE TO DISCUSS THE

CONTRACT AND OUTSTANDING ISSUES UNTIL THE SUMED BOARD MEETS EATER THIS MONTH AND ORGANIZES ITSELF. AT SAME TIME, EGYPTIAMS HAD ASKED BECHTEL TO EXTEND THE CONTRACT WITHOUT ANY SATISFACTURY ASSURANCES THAT THE DUTSTANDING ISSUES WOULD BE EXPEDITIOUSLY I UNDERSTOOD THE BECHTEL GROUP WAS NOW IN TOUCH RESOLVED. WITH STEVE BECHTEL, JR., TO OBTAIN A HIGH LEVEL DECISION AS THE WHETHER TO ACCEDE, AND NOTED I HAD RECOMMENDED WE URGE STEVE BECHTEL TO BE AS FLEXIBLE AS POSSIBLE. ROCKEFELLER SAID HE WILL ALSO GET IN TOUCH WITH STEVE BECHTEL SOME TIME TOMORROW AND SUPPORT PROJECT. HE PLANNED TO SUGGEST TO STEWE BECHTEL THAT HE COME TO CAIRD AT APPROPRIATE TIME TO HELP RESOLVE ISSUE AND ASKED IF I THOUGHT SADAT WOULD SEE HIM. NOTED THAT INITIAL POINT OF CONTACT DUGHT TO BE HEGAZY, BUT TOLD HIM I WAS SURE MEETING WITH SADAT COULD AND SHOULD ALSO BE ARRANGED.

4. OIL EMBARGO: IN A BRIEF DISCUSSION OF THE URGENCY OF LIFTING THE DIL EMBARGO, I POINTED OUT THAT SADAT HAS TRIFFD TO BE HELPFUL. THERE HAVE NEVERTHELESS BEEN SOME RECENT STATEMENTS BY VARIOUS OTHER ARAB STATES THAT THEY MIGHT BE DIFFICULT ON THIS POINT. I SUGGESTED THAT ROCKEFELLER MIGHT NAY A WORD TO SADAT ON THE CRITICAL IMPORTANCE OF THE EARLY LIFTING OF THE DIL MHARGO IF OUR EFFORTS TOWARD WORKING OUT A JUST AND DURABLE MIDDLE EAST PEACE SETTLEMENT ARE TO BE CONTINUED. I ALSO POINTED OUT THAT OUR ABILITY TO BE OF HELP TO EGYPT IN SOME OF ITS ECONOMIC PROPLEMS MUST DEPEND UPON THE EXPEDITIOUS LIFTING OF THE EMPARGO. I REITERATED THAT SADAT HAS SOUGHT TO BE HELPFUL? BUT SUGGESTED THAT A REMINDER OF THE IMPORTANCE OF THIS ISSUE FROM SOMEONE AS PROMINENT AS ROCKEFELLER WOULD NOT HURT.
