### CINCPAC On Payops

Ambassador Sullivan drew attention to a recent message from CINCPAC which outlines its plane to take over psychological operations in Southeast Asia.

### POW Matters

Ambassedor Sullivan said that we had not yet recieved any information on GVN plane to release POWs on the occasion of Tet. He also reported on an incident in the Phu Guoc prison camp in which South Vietnamese guards killed 7 POWs and wounded 14 others when they insisted on decerating PW graves with wreaths bearing the VC flag.

### Visit of Korean Defense Minister

Ambassador Sullivan said that State had requested a report from Saiges on the recent visit of the Korean Defense Minister.

#### Oil Bids

Ambassador Sallivan said he did not know whether or not hide on oil exploration rights had been received by the GVN on the February 10 deadline. Mr. Stearman reported the President had decided that the U.S. should not intervene in this matter.

# Ald Appropriations

Mr. Arthur predicted that there would be some problem with aid appropriations and that there would be an interreguen without even a continuing resolution -- except possibly for pay purposes.
