MEMORANDUM FOR HEADS OF FEDERAL DEPARTMENTS AND AGENCIES

Civil Readiness Exercise 1975 (REX 75) SUBJECT:

By memorandum (copy attached), my Assistant Director for Conflict Preparedness, Mr. Daniel J. Cronin, on May 30, 1974, informed the Emergency Coordinators of all Federal departments and agencies of preliminary plans for the major civil readiness exercise (REX 75) referred to in the Office of Preparedness annual civil emergency preparedness guidance letter dated September 11, 1973.

The timing of REX 75 has now been fixed for the period March 3-14, 1975. Office of Preparedness, General Services Administration Regional Offices 1 (Boston, Massachusetts) and 8 (Denver, Colorado) have been designated to participate and Federal agency field office participation in those regions is requested.

REX 75 presents an excellent opportunity to exercise current continuity of government arrangements, plans, and procedures for Federal civil emergency operations. Additionally, the exercise will test related civil resource management measures during the preattack, transattack and immediate postattack periods of a national emergency which will be simulated in REX 75. Although all departments and agencies are invited to participate, I particularly urge the participation of the Category A agencies designated in OEP Circular 9100.2.

To facilitate our joint planning for REX 75, please provide the General War Preparedness Division, Office of Preparedness, (202) 343-4088, by August 28, 1974, with the name of your Exercise Coordinator who will work with my staff in developing the final arrangements for REX 75. It is our plan to assure that participating departments and agencies derive maximum benefit from the exercise by forming working groups consisting of Exercise Coordinators and members of my staff to develop the detailed civil scenario for REX 75.

: Civil Readiness Exercise 1975 (REX 75) SUBJECT

As indicated in the annual civil emergency preparedness program guidance letter, dated September 11, 1973, the Office of Preparedness is planning a civil readiness exercise (REX 75) to be conducted in March 1975. The exact dates and specific nature of the exercise have not been finally determined; however, the following information is provided for your information:

- REX 75 will interface with a Joint Chiefs of Staff world-wide military command post exercise, PRIME RATE 75, and with the NATO exercise, WINTEX 75. The exercises will include requirements for both national and NATO-wide civil participation.
- A minimum of two OP/GSA Regional Offices will participate in REX 75 and Federal agency participation with these regions will be encouraged.
- The planning accomplished for REX 75 exercises will include preattack, transattack, and immediate postattack. The JCS, however, are also planning a reconstitution exercise, named POLE VAULT 76, to be conducted in the third quarter of FY 1976. POLE VAULT 76 will be based on a reconstitution timeframe scenario, and will use the PRIME RATE 75 attack as a departure point. The JCS have acknowledged the need for civil agency involvement in the design and execution of POLE VAULT 76, and this will be accomplished by a concurrent civil exercise, REX 76. Although civil play in REX 75 will be more procedural in nature than that envisioned for POLE VAULT 76, it will provide our first opportunity to exercise current continuity of government arrangements and concepts developed for emergency operations.
