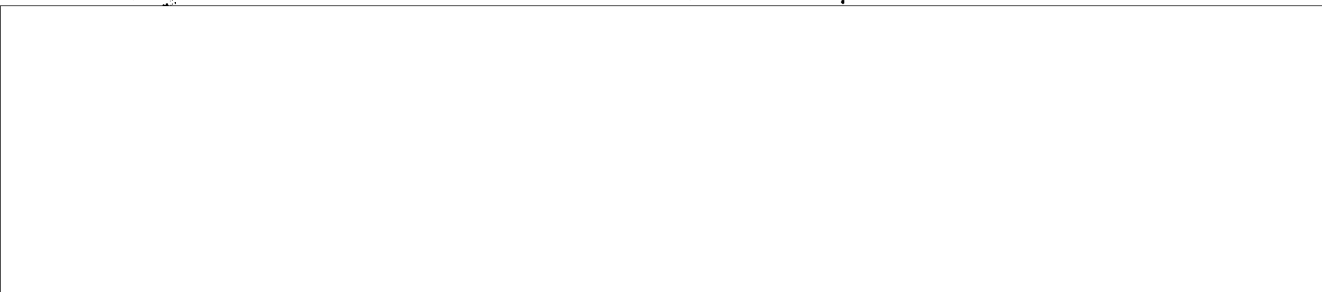

On 29 July, you provided us clearance on release to the Senate Select Committee of sanitized versions of the Intelligence Community post mortems on the Middle East War of 1973, the Indian nuclear test and the Cyprus war.
