PERSONAL FOR MG RYDER, LG FISH, ADM GERHARDT FROM MG GALLOWAY
SUBJECT: TURKNAV REACTIONS (U)

1. (U) CHIEF NAVY SECTION JUSMAT MET WITH ADM TEZCAN, CHIEF
LOGISTICS, AND LATER WITH ADM FIRAT, CTURKNAV YESTERDAY 5 FEB.
2. (C) RECEPTION AND MEETINGS WERE FRIENDLY ON A PERSONAL BASIS.
HOWEVER CONCERN OVER AID CUTOFF WAS VERY OBVIOUS. ADM TEZCAN
EXPRESSED ABSOLUTE DISBELIEF THAT THE U.S. CONGRESS COULD DO THIS
IN DIRECT OPPOSITION TO EXISTING USG/GOT AGREEMENTS. HE STATED
IT WOULD TAKE TURKISH PEOPLE A LONG TIME TO FORGIVE THIS ACT AND
MENTIONED MEMORY OF THE JOHNSON LETTER. HE ALSO EXPRESSED HIMSELF
FORCIBLY ON FACT THAT U.S. WOULD CUT OFF AID TO TURKEY AND CONTINUE
TO SUPPLY GREEKS WITHOUT RESTRICTIONS.
3. (C) ADM TEZCAN STATED THAT TURKNAV WOULD BE FORCED TO CANCEL

HARPOON CONTRACT AND LOOK ELSEWHERE FOR WEAPON SYSTEMS. HE STATED THAT TURKNAY COULD NOT LIVE IN MONTHS OF UNCERTAINTY BECAUSE IT WAS A BIG PROGRAM AND DECISIONS ON MONEY MUST BE MADE NOW. HE ALSO REFERRED TO U.S. PERSUASION TO BUY HARPOON VICE FRENCH MISSILE WHICH REFERRED TO OUR LONG AID RELATIONSHIP. (COMMENT: ADM CHEWNING NOT CONVINCED OF FINALITY OF TEZCAN STATEMENT ON HARPOON.)

4. (C) TEZCAN REJECTED OUT OF HAND THE SECDEF PROPOSAL ON KEEPING ALIVE FMS/FMSCR CASES BY CONTINUATION OF PROCESSING AND PAYMENTS. HE LATER STATED THAT ONLY THOSE CASES PERTAINING TO SUBMARINE BATTERIES AND HARPOON WOULD REQUIRE FURTHER STUDY.

5. (C) ADMIRAL FIRAT EXPRESSED DEEP PERSONAL DISAPPOINTMENT AND APPEARED VERY DEJECTED. (COMMENT: FIRAT HAS BEEN VERY PRO U.S. AND PROBABLY OUR BEST FRIEND.) HE REPEATED FIVE OR SIX TIMES DURING CONVERSATION THAT NO PROBLEM WOULD EXIST HAD TOTAL EMBARGO BEEN PLACED AGAINST BOTH TURKEY AND GREECE ALA FRG ACTION. THE CONVERSATION ENDED WITH FIRAT STATING THAT THESE DIFFERENCES ARE NOT BETWEEN PERSONAL FRIENDS.

6. (C) A NON-MILITARY CONNECTED SOURCE WHO HAS PROVIDED SUPERFICIAL, BUT RELIABLE INFORMATION IN THE PAST QUOTES AN UNIDENTIFIED MINISTER OF THE GOVERNMENT WHO STATES THAT ONE RETALIATORY COURSE OF ACTION BEING CONSIDERED IS THE SYMBOLIC ACTION OF ELIMINATING JUSHMAT FROM TURKEY WITHIN TWO WEEKS. (COMMENT: SHOULD THIS RECEIVE EVEN PARTIAL ACCEPTANCE, IT WILL INDICATE HOW DEEP THE HURT IS HERE AND THAT TURKEY IS PLANNING A COMPLETE REVISION OF HER ARMED FORCE EQUIPAGE WHICH DOES NOT INCLUDE THE U.S.) XGDS 3. UNQUOTE.
