MEMORANDUM FOR THE DEPUTY ASSISTANT TO THE PRESIDENT FOR NATIONAL SECURITY AFFAIRS

US Company on the Demilitarized Zone (DMZ) SUBJECT:

Attached nuto par your regret.

(S) The JCS has recommended, and OSD and State concur, that the US Army Infantry Company on the DMZ in Korea be withdrawn. A cable authorizing the Embassy/CINCUNC to inform the ROK and the Neutral Nations Supervisory Committee (NNSC) of this decision is awaiting NSC concurrence.

(S) In 1971, following withdrawal of the US Army's 7th Infantry Division from the area, a US Infantry Company was assigned responsibility for securing a 500-meter strip astride the United Nations Command. (UNC) evacuation route from Panmunjom. It also manned four designated posts inside the DMZ. Inter alia, the company had the prime responsibility for evacuating the Swiss and Swedish members of the NNSC in a contingency. The company is in addition to the US Army Support Group, Joint Security Area (USASGJSA), consisting of about 175 US military and 50 Korean augmentees, which is located in the DMZ area to support the Military Armistice Commission (MAC) and the Swiss and Swedigh members of the NNSC. This will not result in 5Thing The draw down cules in location in Icorea.

(S) The company's presence is no longer required on the DMZ. The ROK Army is capable of providing the necessary security in the company's area and alternate arrangements utilizing US troops nearby and ROK Army forces can insure emergency evacuation of the Swiss and Swedish NNSC members in an emergency. Removal of the company is in keeping with our policy of lowering the US profile in the area and underscores our recognition of the improved capability and greater maturity of the ROK armed forces. The removal of the company may well be welcomed by the ROK Army since the company's presence complicates the effective operation of the ROK Army regiment whose area of responsibility is split by the company. The company's presence on the DMZ increases the possibility of US involvement in future DMZ incidents and the resulting casualties could have an adverse impact on the US public and Congress. Further it is not anticipated that the removal could affect our relations with the ROK Government or give the wrong signal to other interested nations. Finally Congress has expressed its concern and opposition to the company remaining on the DMZ.


