LATTER KERN NAZI WHO WORKED FOR GERMANS IN POLAND BEFORE AND DURING GERMAN OCCUPATION. STRONGLY BUILT, RATHER FAT, PALE FACE, STRAIGHT NOSE, BLUE GREY EYES, THIN HAIR PARTED IN MIDDLE, GOLD RIDGED SPECTACLES, MANY GOLD FILLINGS, RESIDENCE BOFFOT.
2. KASNER TRACKS LIMITED TO FFV INFO CITED REF WHICH APPARENTLY FROM NEW INTERIOR MINISTRY. FRIDERED NOT IDENTICAL OR RELATED INFO ASSOCIATED NAME KASNER BOB 1947 ON WHICH NUMEROUS TRACKS. WOULD APPRECIATE RECEIVING COPY UPWILL IDENTIFYING KASNER AND ANY INFO UPWILL MAY BE ABLE OBTAIN FROM FFV.
