B. 18:00 An inauguration meeting was held at a chop-house at Ushigome, attended by <u>FURUYA</u> , <u>KURIHARA</u> , <u>SATOMI</u> , <u>SUGANO (KANNO)</u> , <u>BABA</u> , <u>MAEDA Minoru</u> , <u>ITO Tada</u> (a substitute), <u>FUKAZAWA Shoichiro</u> , <u>OKUMURA Zosuke</u> , <u>SHIRATO (or KATO)</u> , <u>SHIMIZU</u> , <u>IKEDA</u> , <u>YAMAGUCHI</u> , <u>KUBOGUCHI (??)</u> and seven other unidentified persons.
