- 1. Mex Ausnit's position with regard to the kesita metallurgical congany is the following: Ausnit and malaxa, through a third company, possess 200,000 shares each out of a total of 2 million shares. Although they held less than 25% of the total capital, August and Malaxa were able to dominate the sharsholders! meeting because the other shares belong to a large number of people who seldom show up at the general meetings.
- 2. As a result of Ausnit's maneuverings, the company decided to increase the capital shares of the company from 125,000 mil.ion to 2,250 million. By controlling the new share issue, Max Ausnit would gain personal control of the whole company. That is the cause of his present conflict with Malaxa.
- 3. Malexa has appealed to the courts which heard the case recently but postponed decision on it. If Ausnit succeeds, the equality which previously existed between him and Malaxa regarding Resita will cease to exist, and Malaxa will be strongly handicapped in any future decision. If Ausnit loses his case, he will remain on the same basis as malaxa, which is exactly what malaxa is aim
