SIGFRIEDO ((OCHOA)) PEREZ TO THE GENERAL STAFF TO ASSIST IN PLANNING A NATIONAL MILITARY STRATEGY WAS A PRETEXT TO ALLOW GARCIA AND FLORES LIMA AN OPPORTUNITY TO CONTROL OCHOA MORE CLOSELY AND TO INFLUENCE HIM.
