STILL UNDISCLOSED, BUT FEEL HE MAY BE IDENTICAL WITH UPA COURIER
REPORTED BY CARTEL TO HAVE ARRIVED ANZON AUSTRIA (REFER MGKA-1024,
PAGE 5) OR ZWIESEL, BAVARIA (REFER ATTCHMT MGKA-1261, PARA 1).

2. REQUIRE IMMEDIATE ANSWER TO QUESTIONS RAISED MGKW-2182 PARA 3.
YOUR FINAL DEBRIEFING OF [] PRIOR DEPARTURE MUST
INCLUDE FOLLOWING:

- A. IDENTITY, DESCRIPTION AND PRESENT WHEREABOUTS OTHER UPA COURIER.
- B. WHEN AND WHERE DID HE ARRIVE U.S. ZONE.
- C. WHAT DISPOSITION WAS MADE OF ORIGINAL MATERIALS DESCRIBED
MGMA-1024, PARA 2E (111). FORWARD ORIGINALS IF POSSIBLE.
- D. DETAILS UPA ORGANIZATION AND STRENGTH INSIDE UKRAINE.

4. REFER WGLA-44 SUBJECT: BANDERA GROUP. THIS REPORT CLEARLY DEMONSTRATES NECESSITY FOR FULL DEBRIEFING SOONEST OF CAPRIFORM CONCERNING HIS FORMER ACTIVITIES IN BEHALF OF BRITISH. EMPHASIS SHOULD BE PLACED UPON HIS RELATIONSHIP WITH AND KNOWLEDGE OF STETZKO WITHOUT INDICATING SPECIAL INTEREST IN LATTER FOR PRESENT.
5. MOB CONTACT WITH STETZKO AND POSSIBLY OTHER UKRAINIAN LEADERS MAY BECOME NECESSARY TO FACILITATE ACCURATE ASSESSMENT AND ANALYSIS STETZKO'S CLAIMS, POSITION, CONTACTS AND TO DETERMINE DESIRABILITY, IF ANY, OPERATIONAL EXPLOITATION OF STETZKO.
