4. NEAL SHER, DIRECTOR OF THE OFFICE OF SPECIAL INVESTIGATIONS (OWI), U.S. DEPARTMENT OF JUSTICE, MICHAEL WORLF, OSI DEPUTY DIRECTOR, AND POLOFF MET THIS MORNING WITH DR. APARECIDO LAERTES CALANDRA, SAO PAULO FEDERAL POLICE SUPERINTENDENT ROMEU TUMA'S CHIEF ADVISOR. (TUMA IS IN BRASILIA TODAY TESTIFYING BEFORE CONGRESS ON AN UNRELATED MATTER.) WE INFORMED CALANDRA THAT FORENSIC ANTHROPOLOGIST ELLIS CURTLEY, FORENSIC ODONTOLOGIST LOWELL LEVINE, AND POSSIBLY A THIRD U.S. EXPERT (WHO HAS SINCE BEEN IDENTIFIED BY U.S. MARSHALS AS NAVY FORENSIC PATHOLOGIST JERRY SPENCER) WILL ARRIVE TOMMORROW MORNING, JUNE 13. CALANDRA SAID HE WOULD TRY TO ARRANGE THIS AFTERNOON FOR SHER, WOLF, AND POLOFF TO VISIT THE MEDICAL-LEGAL INSTITUTE OF SAO PAULO (IML) WHERE THE REMAINS EXHUMED IN EMBU ARE NOW BEING EXAMINED BY BRAZILIAN DOCTORS. (COMMENT: IML IS UNDER THE JURISDICTION OF THE STATE POLICE. BECAUSE THE FEDERAL POLICE HAVE FEW CASES INVOLVING CORPSES, THEY HAVE NO LOCAL FACILITIES FOR FORENSIC PATHOLOGY. END COMMENT.)

5. CORONEL SACK, WHO HEADS THE FRG INVESTIGATIVE TEAM IN SAO PAULO (WHICH INCLUDES TWO OTHER POLICE OFFICERS AND A FINGERPRINT EXPERT) TOLD US HE WAS EXPECTING THREE GERMAN FORENSIC PATHOLOGISTS TO COME TO SAO PAULO, BUT THEIR ARRIVAL DATES HAVE NOT YET BEEN DETERMINED. IN A SEPARATE CONVERSATION THIS MORNING, YEHUDA YALON, ISRAELI CONSUL IN SAO PAULO, TOLD POLOFF THE GOVERNMENT OF ISRAEL HAD NO PLANS TO SEND EXPERTS TO SAO PAULO TO PARTICIPATE IN THE MENGELE INVESTIGATION. ONE OF SHER'S CONTACTS IN THE ISRAELI JUSTICE MINISTRY, HOWEVER, TOLD SHER SENIOR ISRAELI POLICE INVESTIGATOR MENACHEM RUSSEK WOULD COME TO SAO PAULO AS AN OBSERVER.

6. ACCORDING TO U.S. MARSHALS IN SAO PAULO, THE WIESENTHAL INSTITUTE MAINTAINS PLANS TO SEND A GROUP OF MEDICAL EXPERTS HERE.
