(c) Based on a 2008 United States Secret Service investigation that identified an Agency contractor as possessing a degree from a known diploma mill, the Office of Inspector General (OIG) initiated a proactive investigation on 5 August 2008 into Agency staff claiming degrees from non-accredited institutions. OIG matched a list of known, unaccredited institutions against Agency BIO information to identify any individuals who had provided degree evidence to Human Resources. 


