SUBJECT : Project MKULTRA, Subproject 125

1. The purpose of Subproject 125 is to continue support for the research activities in psychopharmacology of Dr. [redacted] in accordance with the attached proposal. Funds granted would be used to pay the salary of one graduate research assistant, and commits the Center to putting a greater share of its professional assets into the research.

2. Concrete results of the first year's effort are reflected in two articles for publication: [redacted] (accepted for publication); and [redacted] (in preparation). This methodological work, which is being closely monitored by Dr. [redacted] is attempting to isolate some very subtle effects which are highly pertinent to evaluating results from the Agency's more general work with psychopharmacological agents.

IN LIGHT OF RECENT EVENTS, I.E., CONSULTATION WITH DR. [REDACTED] THE AVAILABILITY OF A [REDACTED] TRAINEE IN EXPERIMENTAL PSYCHOLOGY, AND THE UNAVAILABILITY OF ONE OF OUR RESEARCH ASSISTANT APPLICANTS (THE THREE MONTH APPLICANT), WE WOULD LIKE TO REVISE OUR CURRENT GRANT REQUEST DOWNWARD TO \$6500. 





1. Mr. [REDACTED] THIRD YEAR GRADUATE STUDENT IN PSYCHOLOGY, HAS INDICATED HIS AVAILABILITY AS A PSYCHOLOGY RESEARCH ASSISTANT FROM SEPTEMBER, 1960 THROUGH JUNE, 1961.

2. HIS PARTICIPATION AS AN ASSISTANT WILL ENABLE CLINICAL PSYCHOLOGY SECTION TO EXPEDITE A NUMBER OF ON-GOING STUDIES AND TO UNDERTAKE A NUMBER OF CONTEMPLATED INVESTIGATIONS RELATED TO PSYCHOLOGICAL PROBLEMS IN AGING, LONG-TERM INSTITUTIONALIZATION, AND LONG-TERM ILLNESS.

EARLIER STUDIES OF HUMAN FIGURE DRAWINGS OF AGED SUBJECTS HAVE REPORTED THAT THE AREA, HEIGHT, AND CENTEREDNESS OF SUBJECT'S HUMAN DRAWINGS ARE RELATED POSITIVELY TO SUBJECT'S DEGREE OF INSTITUTIONALIZATION. THESE REPORTS WERE BASED ON COMPARATIVE STUDIES OF INSTITUTIONALIZED AND NON-INSTITUTIONALIZED AGED SUBJECTS. IF CONCLUSIONS HOLD, THEN THE DIMENSIONS OF THE FIGURE DRAWINGS SHOULD DISTINGUISH ALSO BETWEEN DIFFERENT DEGREES OF INSTITUTIONALIZATION OF SUBJECTS WITHIN AN INSTITUTION. HUMAN FIGURE DRAWINGS WILL BE OBTAINED BY MEANS OF STANDARD PROJECTIVE TEST INSTRUCTIONS FROM INTERMEDIATE SERVICE PATIENTS AND DOMICILIARY MEMBERS WITH THE SAME GENERAL DISABILITIES. HEMIPLEGICS, DIABETICS, AND EMPHYSEMAS WILL BE CONSIDERED SEPARATELY. 2. It will enhance the status of the [Redacted] with respect to the [Redacted] and its growing research apparatus and will be a genuine contribution to the areas studied (drugs, aging, etc.). (B)
3. [Redacted] and I will actively work with them, participating in every stage of planning, analysis, reporting, etc. The program will thus represent a sort of staff activity of the [Redacted]. The people at [Redacted] are more than willing to receive our advice and suggestions. (As a matter of fact, their current research project was proposed and designed by me.) (B)
