1. The aim of this subproject is to provide funds for an increase in the scope of that portion of Subproject 48 which deals with the over-all returnee interrogation and rehabilitation program now being carried out by the [REDACTED] B  
B [REDACTED] Since it is impossible to estimate in advance the number of subjects to be handled under this program, it will be necessary to enlarge its scope from time to time.

2. Subproject 21 was set up originally for the purpose of providing a drug screening facility at the [REDACTED] B  
B [REDACTED] The total cost of the program amounted to \$5720.00. Unfortunately, internal politics at the [REDACTED] made it im- B possible to carry out the program as planned, and so no funds were ever expended in this Subproject. The basis for the change of Subproject 21 from its original goal to the present one is based upon an identical case where Subproject 10 was converted B for use in the [REDACTED] project after it became evident that the funds committed under it originally for another purpose could A not be used. [REDACTED] has since audited Subproject 10 without questioning this type of handling.

3. Accounting for funds expended by the contractor in this subproject will be reflected in the general accounting for Subproject 48.

4. The total charges for this project will not exceed \$5720.00 for a period of one year ending 30 June 1956.

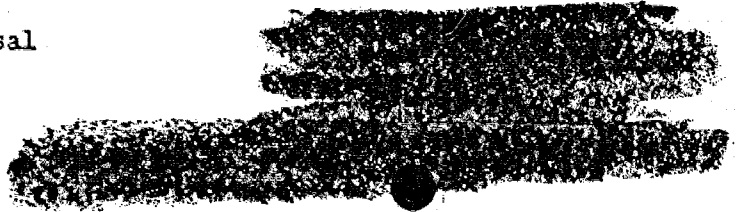
