SUBJECT: Project MKULTRA, Subproject 40

1. Subproject 40 was established to finance the research of Dr. [REDACTED]. Dr. [REDACTED] has been primarily engaged in evaluating various testing techniques for LSD-type compounds, both in the laboratory and in normal human beings. C

2. At the request of TSS/CD, Dr. [REDACTED] has agreed to undertake an entirely new phase of research. Starting 1 July 1956, Dr. [REDACTED] will undertake to investigate the feasibility of utilizing aerosols as a delivery system for various psychochemicals of interest to TSS/CD. Dr. [REDACTED] expects to expend 60 percent of his budget for this investigation. C

3. In addition to the above investigation, Dr. [REDACTED] plans to continue his research of the LSD blocking effect of various tissue extracts. It is planned that the mechanism of this reaction will be more fully explored and the results be applied to human studies. This phase of the overall program is expected to represent 20 percent of the budget. C

4. A third phase of Dr. [REDACTED] program will be a continuation of his studies on non-psychotic humans with a view toward maintaining this test group. The primary purpose of this group will be to serve as a human experimental body for items obtained from 2 and 3 above, in addition to ad hoc testing requests emanating from TSS/CD. C

The estimated cost of the program, starting 1 July 1956, for a period of 15 months will not exceed \$40,000. To this must be added \$1,600 representing a four percent service charge to the [REDACTED]. Thus the total cost is not expected to exceed \$41,600. Charges should be made against Allotment 6-2502-10-001. B

5. The principal investigator shall submit to the sponsor once a year an audit of expenditures of monies by a Certified Public Accountant. It is expected that an annual summary accounting will be

6. The principal investigator shall, upon the completion of the program year, return to the sponsor any unexpended funds that have been advanced for the research program.

7. Title to permanent equipment purchased with funds furnished to the principal investigator shall remain with the sponsor, except that title to equipment purchased from funds furnished by the principal investigator to the [REDACTED] shall be retained by that institution in lieu of higher overhead rates. Upon completion of the program the sponsor will instruct the investigator as to the method and mode of disposal of those items of permanent equipment to which the sponsor retains title. The principal investigator will submit an annual inventory of permanent equipment (exclusive of [REDACTED] when the annual certified accounting is submitted. **B**

8. Accounting for travel reimbursed by funds administered by the [REDACTED] shall conform with the practices of that organization. Travel expenses paid from funds administered by the principal investigator shall be documented and maintained on file by the principal investigator for a period of two years from the date of travel. Documentation shall be available for inspection by the sponsor. **B**

May I thank you for the interest shown by your Company in the project at [REDACTED]

should like to enlist your aid, if I may, for continuation of the project along the following lines.

1. Aerosol Studies. The therapy of individuals by means of aerosols is of great significance in medicine. A hitherto unexplored area of aerosols is the delivery of nebulizers using nonaqueous solvents. It is proposed that studies be made of organic materials in non-aqueous solvents and their mixtures with water to determine nebulizer delivery over prolonged periods of therapy. (60 per cent of budget).

2. As you know, the blocking of LSD reactions has been claimed by many pharmaceutical houses, although none of these claims have really been substantiated. It is proposed that recent investigations by me on tissue extracts be further explored with a view toward discovering what it is in these extracts that blocks the LSD reaction, keeping in mind possible application of these compounds to experimental and clinical psychoses in man. It is understood that this part of the project will be discontinued December 31, 1956. (20 per cent of budget).

3. Continuation of studies on non-psychotic humans with a view toward maintaining a test group, as well as to provide experimental work in a frame of reference different from that frame of reference incorporated by items 1. and 2. of the foregoing. However, it shall be the primary purpose of the nonpsychotic test group to test the results obtained by items 1. and 2. (20 per cent of budget).

It is anticipated that the foregoing budget may be amplified by supplementary funds to be received from foundations.

The following is the proposed budget. Owing to the uncertainty of plans for the fiscal year 1956-1957, I should like, if possible, to have the privilege of utilizing the proposed budget to September 30, 1957 rather than to June 30, 1957.

SUBJECT: Project MKULTRA, Subproject 40

1. During the period 3 July 1953 to 3 July 1955 Dr. [REDACTED] furnished a total of \$76,420.00 to [REDACTED] Hospital for a portion of the work on an approved MKULTRA activity (see Sub-projects 7 and 23). During this same period the Hospital expended a total of \$84,605.32. From the other phases of Dr. [REDACTED] project there was an unexpended balance of \$7,820.58 during this two-year period. Thus there was a deficit of \$8,185.32 on the [REDACTED] portion and an excess of \$7,820.58 on the remaining portions, leaving a net over-expenditure of \$364.74. B

2. [REDACTED] financed its over-expenditure by applying unreturned funds furnished that institution during the year 3 July 1952 to 3 July 1953 under RD-37. The entire over-expenditure occurred during the year 3 July 1954 to 3 July 1955 and occurred because [REDACTED] Hospital included previous unexpended funds in their total balance and included these funds when indicating to our contractor, Dr. [REDACTED], the unexpended balance of funds on hand. The internal difficulty created for TSS/CD is that the RD-37 funds furnished in 1952-53 must be accounted for separately from the MKULTRA funds furnished after 3 July 1953. B

3. For security reasons there is no way to recover the funds [REDACTED] Hospital expended in excess of what they received after 3 July 1953. These funds were all expended in legitimate activities in connection with an approved MKULTRA project. B

4. A total of \$364.74 of current FY 56 funds is therefore required to compensate for RD-37 funds which were expended against an approved MKULTRA project.

5. A summary of payments and expenditures from 3 July 1952 to 3 July 1955 is attached.

I was very glad to have the privilege of talking over with you the possibility of continuing research next year. In accordance with our discussion, the project would be set up primarily at [REDACTED] provided that I can make a firm commitment before anyone else gets the space. In addition, Dr. [REDACTED] needs the approval of the executive committee which I believe should be routine since a precedent has been set up during the past summer when normal subjects were used.

As I visualize the project, the commercially important compounds will be studied about half of the research time with the rest of the time devoted to antidote and synergy experiments on man as well as experiments on lower forms. This partition is necessary as we discussed to provide the sanction required by all parties concerned and is contingent upon the following budget:

In accordance with our conversation I am planning to try to raise additional funds from other sources as well as [redacted]. If an additional \$15,000 can be raised from other sources I believe that the study of industrially important compounds can be increased appreciably so that 80 to 90 per cent of the research time can be allocated to these compounds.

At this time, although not directly connected with the foregoing, but indirectly connected with the project as a whole, has been the cooperation which I have received from [redacted]. As you know, they have provided me with many compounds and have cooperated in many ways in facilitating the program of the experiments. It has been a natural consequence of this cooperation, especially because of the claims which I have made with their product (reprint enclosed) that these therapeutic claims be broadened to include the use of their product in group therapy. The transcriptions of our data make it appear that certain basic postulates of the use of the drug in group therapy may be obtained by screening the data. I had proposed to [redacted] before your expanded 1955-1956 project materialized and at a time when I thought that no project could be planned, that [redacted] provide me with a psychologist interested in group therapy to screen the data. I know on the basis of the conversation here that you thought that perhaps this form of support might not be desirable. However, I wonder if it would be wise for me to refuse their support. I do not believe that they would get any closer to the project than they are now. As a matter of fact, the work could be done here in my office and not at [redacted]. Indeed, I had visualized having a psychologist doing it in his own home or office since this will be just screening verbatim transcripts. In view of our discussions pertaining to my position in the general field with particular reference to the ease with which I could participate in the exhibits (no clearance) I wonder if it would be wise for me to refuse funds for an investigation of data away from the Biological Laboratory designed to focus attention on therapy.
