MEMORANDUM FOR: THE RECORD

SUBJECT : Project MKULTRA, Subproject 82

1. The purpose of this subproject is to provide funds for the conduct of a study of [redacted] refugees who were admitted

F/B to [redacted] after the [redacted]. As indicated in the attached proposal, the work will be carried out by Professor [redacted]

C [redacted] of the [redacted]

F/B [redacted] Extensive conferences on the subject were carried out between Professor [redacted] and re- C presentatives of the [redacted] while B

C Professor [redacted] was in this country. The [redacted] B of the [redacted] has approved the project.

2. The primary reason for the necessity of conducting a further study of these refugees lies in the fact that those people who were admitted to the U. S. after the [redacted] B made up a highly selected group. Because of the immigration restrictions, this group consisted of the western-tied rightist elements who had never been accepted completely in the present [redacted] B society. As such, they had spent their lives being discriminated against and suspected by the communists in their own country. Knowledge of such individuals can contribute little toward an understanding of the dynamics of the

^{F/B} [redacted] On the other hand, those ^{F/P} [redacted] who were admitted to the various ^{F/B} [redacted] countries such as ^{F/B} [redacted] consisted of a cross section of the ^{F/B} [redacted] population and as such included many ex-communists who had become disillusioned with the regime and so ^{F/B} [redacted] but who still have a basic stake in the eventual conversion of their native country to a more acceptable political status. In short, these are the people who are basically interesting to the Agency. They will produce the patriots who will return to ^{F/B} [redacted] to continue the struggle against communism in one way or another.

3. The ^G [redacted] has been consulted on this matter and the people concerned have indicated that they regard it as an important research project. They also pointed out that they had been asked by the ^{F/H} [redacted] to supply any possible help that they can in con-
^{F/B} [redacted] nection with the ^{F/B} [redacted] aspects of the ^{F/B} [redacted] now living in ^{F/B} [redacted]. Any such information turned up in the project could very easily be made available for this purpose.

4. A further and very important aspect of this subproject is the fact that it will provide an entree into one of the foremost ^{F/B} [redacted] psychological research centers. Such a connection has manifold cover and testing possibilities as well as providing a base from which to take advantage of developments in that area of the world.

5. This project will be handled as a research grant-in-aid from the ^{F/B} [redacted]. The funds

PLAN OF A RESEARCH PROJECT ON THE REFUGEES

After the [redacted] some [redacted] refugees have been admitted to [redacted] at this moment most of them have found a place in [redacted] economy. The adaptation to the new social situation, however, causes sometimes difficulties.

It is of great interest to make a study of the adaptation of the [redacted] refugees to the new situation.

When coming to [redacted] they probably built up a set of expectations concerning the situation they would find. These expectations probably were shaped by their personality structure, environmental influences (including cultural influences), amount and contents of information on the [redacted] countries - particularly [redacted], stereotypes, etc.

After their arrival in [redacted] they probably faced a situation which in some or other way differed from what they had expected, i.e. there arose a conflict between the expected situation and the perceived situation. This conflict may have led to different types of adaptive behaviour.

The question we should like to tackle is: What are the main problems of adaptation of the [redacted] refugees, what stresses do they experience, in which ways do they try to solve their conflicts and which - if any - are the main modes of adaptation they display.

In doing this we plan to take into account the personality structure and environmental and cultural influences.

Particularly we shall try to ascertain what was the basic motivation for leaving [redacted] e.g. fear for punishment, the desire to work for [redacted] abroad, sheer adventure. It also seems of great importance to find out if any of the refugees should be looked upon as maladjusted prior to their arrival in [redacted].

A comparison of these maladjusted cases with the mentally healthy in terms of their adjustment to the conditions of life in [redacted] may be regarded as an experiment of the ex post facto type.

We intend to conduct this study with a limited number of refugees (some 70 or 80), so as to make possible a broad clinical approach. We shall not look for statistical representativeness, but shall only try to gather enough information to build comprehensive case studies. By studying and comparing

these we hope to find common traits which can lead to formulation of hypotheses for further research on more extensive groups of refugees.

The instruments to be used are:

1. A battery of psychological tests. This will include the Wechsler-Bellevue, Roschach and T A T, as they are in common usage in this country and also have been used by our American colleagues. To this we may add the Mäscher Colour Preference Test, The P-scale, and a personality inventory of the M M P I of Maudsley type.
2. A non-directive interview which will be so structured so as to cover the areas of opinion, feeling and behaviour mentioned above. Both tests and interviews will be administered by ^{FIB} speaking social scientists (both psychologists and sociologists). As these specialists are generally engaged in relief work for compatriots in the towns they live in, they will do their interviewing and testing their groups in other towns. The interviewers as they are ^{FIB} themselves, have left ^{FIB} before ^{FIB}

We have had a few talks with social workers on the staff of the official refugee-organisations. They have formulated questions of great practical interest to their work. However, we feel that it is better first to gather more knowledge about the problems concerned before trying to lay down rules for social action.
