having killed, among others, four to six American airmen who had pareshuted from a disabled craft inside Hungary. The evidence was strong enough to result in the sentencing of three of NEV's colleagues to death and these men were duly executed by American MFs in Salaburg. The circumstances under which NEV was released from American enstody menths after his life-sentence was imposed, are presedingly passling in view of the fact that a crucial Hungarian witness arrived in Salaburg three days after the trial of NEV and company had been completed, with enough demaging systimess testimony of NEV's role in the ensecution of the fliers to have cent hir to the salaburg with his consider. This testimony was never taken by the court. A parsistant but unconfirmed report circulating in 1747 among American military intelligence circles in America indicated that NEV and quietly released upon high-level intervention from the United States, and that Vatican contacts had much to do with his release. He arrived in Rome on 21 August 1947 as a reported Musyarian intelligence agent and as a former secretary of the Hungarian Council of Ministers (probably in the brief Arrow-Cross government of Ferenc SZALASSY in 1944-45). He was reported living at the Hungarian Academy in Rome and was allegedly being provided with funds for a network by .CECH, Hunjarian Charge D'Affaires in Rome.
 - 4. Traces on Martman LAUTERBACHER are negative.
- 5. Traces on Abbul Hadi HEJDUB indicate that one Cherif Hen Hadj Leimmad Lidus I, probably identical with MEDUB, was one of five Arab agents in 19.4 of the German consul Hans Herbert Paul SHYDEL in Tetuan,
