<p>THE FOLLOWING INFORMATION IS EXCERPTED VERBATIM</p> <p>1. If the Cabinet Research Chamber (CRC) is enlarged by a new YOSHIDA government to become the CIA of Japan, YOSHIDA will not retain MURAI Jun (2625/0064/7311) as its head. Possible successors to MURAI are KISHIMOTO Yoshihiro (1489/2609/5030/1689) and <u>OGATA Taketora</u> (4872/2455/4554/5706).</p> <p>5. There is a good possibility that YOSHIDA might name OGATA to the post, particularly if he feels the organization needs the prestige of a well known political figure. Should this occur, the organization would probably be as follows:</p>
