- 2. AT JAP INVITATION AND WITH MY APPROVAL ME: BRIEFLY 5 NOV 52 WITH OGATA TAKETORA, CHIEF CABINET SECRETARY NEXLY FORMED YOSHIDA GOVT. PURPOSE OF MEETING WAS FOR OGATA TO MEET A WHO HE UNDERSTOOD TO BE MEMBER OF "U.S. INTELLIGENCE".
- MHEN C IDENTIFIED HIMSELF TO OGATA IN TERMS OF DYCLAIM AFFILIATION OGATA EVINCED KEEN PERSONAL INTEREST IN INTELLIGENCE GENERALLY AND IN DYCLAIM SPECIFICALLY.
