SOURCES AND METHODS INVOLVED

1. (C) Information on file indicates that Helmut Paul Ernst Julius OHLBRECHT, born 22 March 1908 in BERLIN, was of interest to the BfV in May 1960. (B-2)

2. (U) Undated information on file indicates that one Helmut Ohlbrecht, born 22 March 1908, residing in BERLIN/Charlottenberg, Steffekstrasse 36, not further identified, was promoted to the rank of SS Untersturmfuehrer in November 1934. In 1938, he was listed on the staff of the SA Oberabschnitt Ost. He was appointed to the Air Ministry in November 1941 with the rank of SS Sturmabfuhrer. His NSDAP number was: 452309; SS number: 22293. Listed among his party decorations was a Totenkopf Ring. (F-6) (This paragraph FOR OFFICIAL USE ONLY)

3. (C) Information from a BfV report dated 9 August 1954 indicates that one Helmut Ohlbrecht or Ohlbricht, residing in West BERLIN, not further identified, was alleged to have been a member of the Gehlen organization in West BERLIN. (F-6)

4. (U) Available records disclose no further pertinent information.

COMMENT: (C) The above information may be released to the BND. Additional information indicates that one Helmut Ohlbrecht, residing in BERLIN/Charlottenberg, Friedbergstrasse 36, bei Neubauer, not further identified, was the subject of a request for CIS coverage from the 606th, not further identified, on 16 November 1953. Ohlbrecht was allegedly engaged in pro-Western political-intelligence activity in West BERLIN. (B-2)
