| <p>1. We are hesitant to trace Subject with UPHILL. To query either @BROCK or @WINTERSTEIN would call undue attention to our request, and to forward the request through routine name trace channels would be regarded by UPHILL as a fishing expedition in the event OLBRUCH is their man. This however is not our primary concern. Were we to receive a positive reply from UPHILL we would only be confirming what we already assume to be probably true, and we would risk exposing [ ] as [ ] If Subject is an UPHILL agent he probably is reporting on [ ] as [ ] s on him. At least this is the way it looks from here. we admit it may well be, for reasons which cannot be apparent to us, that no risk would be involved, but we would like to be certain before proceeding with any action vis a vis UPHILL. Please advise.</p> <p>2. [ ] We would be very interested in any additional information you might develop on OLBRUCH. The information you reported in [ ] 2260 leads us to believe he is probably an UPHILL agent.
