## Traffic in Passports

- 1. It is reported that the war-time traffic in passports continued to flourish in Switzerland, but whereas the kind of passports in question were formerly procured in Switzerland, London is now reported to be the present source. Cuban, Argontinean, Uruguayan and Gustemalan passports are said to be obtainable from not at the respective Consulates in London. They cannot be purchased or used in Great Britain, but must be sent for. The price varies between 5,000 and 10,000 Swiss francs.
- 2. These passports are accompanied by a document called a "navicert" which permits the purchasers in Switzerland or elsewhere to travel to some designated place where they pick up the passports that have been issued in their own or fulse names.
- 3. Two Geneva lawyors are said to be involved in this traffic, a Dr. Pierra Emile ATTESLATER, address, Rue de la Tour de l'Ile 7, who is on the proclaimed list, and a certain SCHTCARY, recently removed from the list. Two other lawyers of dubious reputations, LACHENAL and GUINANT, both of them atterneys for the noterie a Michel DLIAN, are believed also to be interested. They make out the applications which are then forwarded to London by the local Cuban, Argentinean, Truguayan or Guatemalan Consulate.
- 4. One of the old timers in this business, Georg 'ANTULLO of Geneva, is said to be still active in passport traffic although he is no longer Consul for San Salvador. CHAVAZ in Lisbon is also believed to be trafficking in Bolivian passports.
