 In 1941 O. applied for NSDAP membership but failed to sign the primary application form. A summons from the competent party section to correct this mistake did not reach him before a ban on admission of new members became effective. In a letter to the Reich Treasurer of the NSDAP, dated Aug 19, 1942, he requested in vain to continue the processing of his application by way of exception despite the blocked membership.

 Member of the 1-SS (entry-date is not given, presumably 1939),
 ranks: SS-Hauptsturmfuehrer/Captain (June 1, 1939),
SS-Sturmabfuhrer/Major (April 20, 1940),
