4. Land Ministries. The central Ministry of Health works, in many of its capacities, through the appropriate Land ministry or department, or through the Berlin office. In early 1952 the following Land offices existed:

In June 1952, however, the Land health ministries were being slowly dissolved. It was understood by high officials of the central Ministry that their staff would be increased correspondingly. There were also rumors in the East German Ministry of Health that the new enlarged central Ministry would move out of Berlin, but there appeared to be no basis for this rumor.

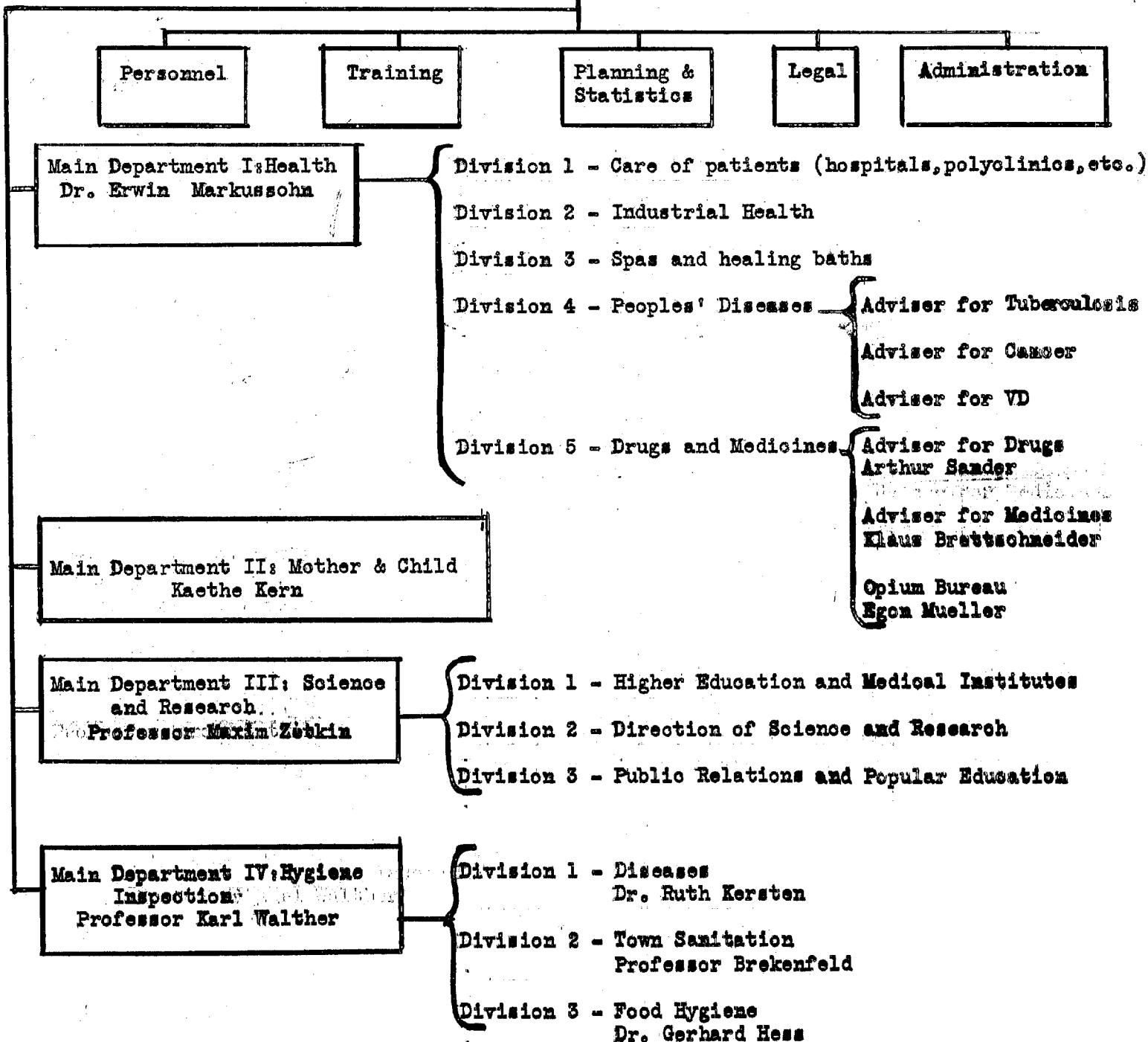
