- 1. Reference is made to your memorandum dated 4 June 1958 requesting a covert security approval for the Subject to permit his use in New York City by SR/3 in connection with Project ARRODYNAMIC.
- 2. On 24 June 1958, C I of SR/3, PP orally advised that Subject contemplates a trip to the Brussels World Fair in the very near future in connection with his duties under ARRODYNAMIC. It is understood that Subject is not witting of Agency interest in his proposed trip or his regular employment for AERCODYNAMIC. It is also understood that Subject has no clearance status of any kind and is under no contractual relationship with the Agency.
- 3. In accordance with the provisions set forth in Clandestine Services Instruction No. 10-5 and Field Regulation 10-215, a provisional covert security approval is granted for the use of the Subject as described in paragraph 2, above. This will confirm the verbal provisional covert security approval granted to ______ on 2h June 1958.
- 4. It is pointed out that the provisional covert security approval is issued only in connection with the Subject's proposed trip to Brussels. Further, it is understood that the request for a full covert security approval will be processed in regular course in connection with his regular employment with AERCHYNAMIC in New York.
- 5. Subjects of provisional covert security approvals are not to represent themselves as, nor are they to be represented as, employees of CIA.
- 6. Your attention is called to the fact that a provisional covert security approval does not constitute complete compliance with the provisions of CIA Regulation 10-210. Therefore, if you
