MEMORANDUM FOR THE OFFICER IN CHARGE:

SUBJECT: von ROER, Hans-alias Herman RICHTER

1. For your information, subject who recently escaped from custody in Milan during the transfer of his person from SCI/E, Genoa to CIC Milan, was re-apprehended by the Questura of Como on approximately 7 March, 1947, and is now at the disposition of this office at Questura Marassi Prison, Genoa after having been turned over by SCI/E, Genoa.

2. Subject had previously escaped from RIMINI (April, 1946) and his return thereto was automatic. However, inasmuch as the Questura of Como requested by letter (~~see attached~~) that, should liberty from allied internment be proposed for Subject, he be immediately placed at their disposition for expulsion from Italy proceedings, this office requested guiding instructions from CIC Headquarters.

3. Telephonic information from Chief CIC, via Milan Detachment, revealed that Subject is wanted by War Crimes Commission in Germany and a report on Subject was therefore immediately requested.

4. Pursuant to telephonic instructions from Chief of CIC, via Milan Detachment, the following information is being submitted for his disposition.

- a) Two photographs of Subject
- b) Two letters from Questura of Como for Subject
- c) Copy of interrogation report made by SCI/E, Genoa
