- l. For your information, subject who recently each ped from custody in Milan during the transfer of his person from SUI/I. Genon to CIC Milan, was re-apprehended by the Questure of Como on approximately T March, 1947, and is now at the disposition of this office at Questure Marcasi Frison, Genon after having been turned over by SUI/E, Genon.
- 2. Subject had previously easiped from RIMINI (April, 1946) and his return thereto was automatic. However, in agmich as the Questure of Come requested by letter (see=attached)—that, should liberty from allied interment be proposed for Rebject, he be in-mediately placed at their disposition for expulsion from Italy proceedings, this office requested guiding instructions from CIC Head-quarters.
- 5. Telephonic information from Chief CIG, via Hilan Detachment, revealed that Subject is unuted by War Crimes Counteston in Germany and a report on Subject was therefore immediately requested.
