This is a non-commercial request pursuant to the Freedom of Information Act, 5 U.S.C. § 552, as amended, and the Privacy Act of 1974, 5 U.S.C. § 552a, for a copy of all records in possession of the Federal Bureau of Investigation on myself or which makes reference to myself. Attached please find a Certificate of Identity.

I wish to make it clear that I want all records in possession of the "identifiable with" this request, even though some of the records may be located in a Field Office. I want all Field Offices searched. I want all records as they appear in the "main" file, "see references," and in all other locations.

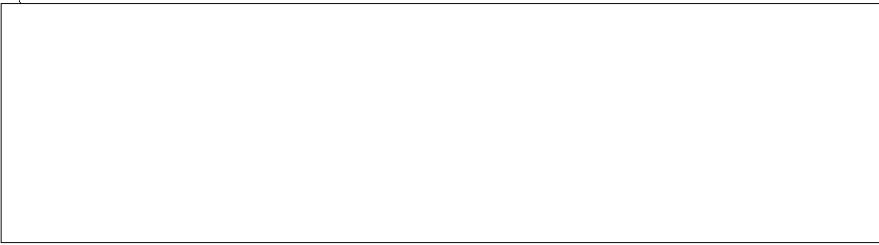

I request a complete and thorough search of every system of records as well as every locations where records are maintained.

This request specifically includes, but is not limited to "main" files, "see references," including but not limited to numbered and lettered sub-files, 1A envelopes, enclosures behind files (EBF's), bulky exhibits, and control files. I also request a search of all "Electronic Surveillance" (ELSUR) indices and indexes and any similar system for locating electronic surveillance files. This request includes illegal electronic surveillance conducted by the U.S. or any other agency wherein records are located within U.S. files. I want all records to be produce with administrative markings, and all reports to include administrative pages.

I want a copy of all "see reference" cards, see index cards, main index cards, abstracts, search slips (including search slips used to process this request), file covers, multiple copies of the same documents if they appear in a file, tapes, handwritten or typed logs of any electronic surveillance, handwritten or typed logs of any physical surveillance (FISUR), and copies of videotapes and photographs. If any type of voice analysis has ever been made, I want a copy of the reports.

Please search "DO NOT FILE" files, SAC safes, special file rooms, and offices of all officials.

The information requested is for personal use and will not be used for any commercial purposes.

The information and documents I am requesting are outlined herein as follows:

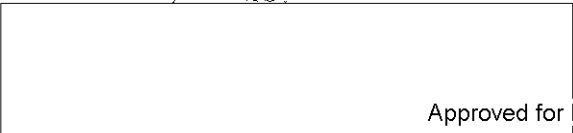
