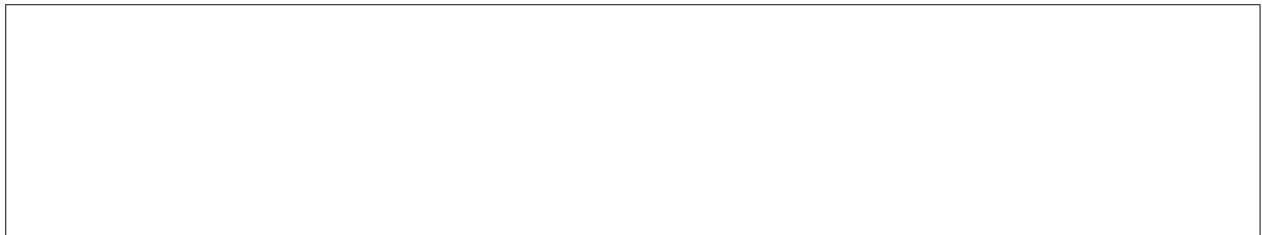

As you are aware, the FOIA permits fees to be charged only for search and copying costs and not for review of materials.

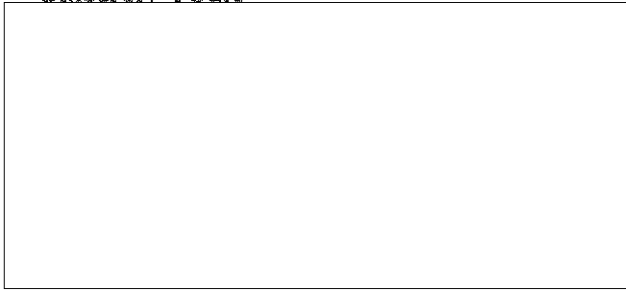

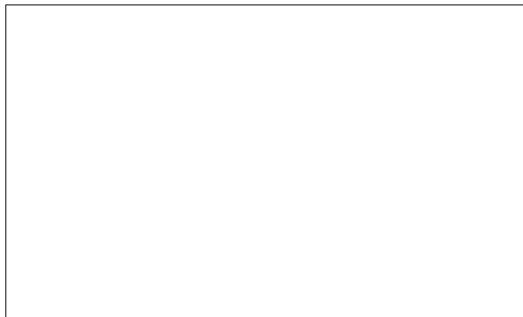
