- 4. Nature of contacts with the Baroness Gunhilde THYSSEN, nee won FARRICE.
- All details on contact, if any, with Hans Wilhelm ECCEN.
- 6. Subjec's contacts with, and activities of, Dante TUNINUTTI.
- 7. All details on background and issuance, 5 Nov. 1943, of arms permit to subject by EINSATZKDC Rome, EdS ITALIEN.
- 8. Reasons for and persons contacted during subject's trip to Rumania in August 1943. Was this trip facilitated in any way b. German authorities? If so, by whom? and why?
- 9. Full dotails, proferably in chronological succession, of the contacts between subject (and his wife) with Major ENGELS, Gence.
