SUMMARY

At the end of August Baron PARILLI informed that DOLLMANN and WENNER, having escaped from the Allied PW Camp, were given false identity cards by SIM. Both being held by SIM and Cardinal SCHUSTER in a Milan insane assylum. Both are being used in a determined Right wing and Vatican maneuver to discredit Allied surrender in Italy and build up Nationalistic anti-allied feeling on all out propaganca theme that Cardinal SCHUSTER saved Italy from German scorched earth intentions by personally negotiating surrender. Project was launched in Milan press supported by phony affidavits obtained by SCHUSTER's secretary, Don BICCHERAI and GHISETTI of SIM, which DOLLMANN and WENNER were forced to sign. It also included blackmail documentation against PARILLI and others who had worked with Americans. PARILLI concluded that both were being blackmailed and had contemplated defectin to Russians but were scheduled to be transferred to another place, allegedly a Jesuit convent. PARILLI spent 180,000 of his own lire in making up for the harm done. Whether authorized or not, HUSSMANN and PARILLI made promises to DULIMANN. DULIMAN clearly participated in the secret I.S. phase of negotiations. These promises were made to DULIMANN by PARILLI and HUSSMANN during their incarceration by SIM in Milan.
