SUMMARY

At the end of August Baron PARILLI informed that DOLIMANN and WENNER, having escaped from the Allied PW Camp, were given false identity cards by SIM. Both being held by SIM and Cardinal SCHUSTER in a Milan insane assylum. Both are being used in a determined Right wing and Vatican maneuver to discredit Allied surrender in in Italy and build up Nationalistic anti-allied feeling on all out propagance theme that Cardinal SCHSTER saved Italy from German scorehed earth intentions by personally negotiating surrender. Project was launchedin Milan press supported by phony affidavits obtained by SCHUSTER's secretary, Don BICCHERAI and CHISETTI of SIM, which DOLIMANN and WENNER were forced to sign. It also included blackmail documentation against PARILLI and others who had worked with Americans. PARILLI concluded that both were being blackmailed and had contemplated defectin to Russians but were scheduled to be transferred to another place, allegedly a Jesuit convent.
