1. Reference is made to identity request No. 654, your headquarters, dated 9 November 1948, subject as above; to IRG, your headquarters, dated 2 March 1949; to identity request No. 603, Headquarters 1970th OIG Group, dated 18 February 1949, subject PKELSKY, Vladimir and HOZEK; and to IRG, this headquarters, IRG 2 January 1949, subject as above.

2. PKELSKY, Vladimir was dropped by this organization on 28 March 1949 for cooperation with CIC which, extensive activities in the Migration and for passing on IS information to FRCHALA, Leden. PKELSKY is the official representative of General IRHALL, in Bohemia and perhaps in the entire US Zone. He is also the editor of SPRATA CIGKE MAHOVNI BRATSTVI, which is a well-known Czech Migration newspaper.

3. HOZEK, Yeklav was employed with this organization on trial, but was dropped on 28 March 1949 for the same reasons as PKELSKY and perhaps is identical with HOZEK.

4. RAMAK, Miroslav and FRCHALA, Leden are not known to this project, however, it is quite possible that they are employed by PKELSKY, as it is known that he employs couriers, contact men and confidential agents in the OSM.

5. SMYKAL, Gustav is not a member of this organization, but we have him RECORDED as SMYKAL born 21 January 1923 and living at Camp LECHFIELD. He was arrested in March 1948 by OSM as a suspected Czech agent, but later released for lack of evidence.

6. No further information is available re subject organization.
