
SUBJECT : Persons Arrested in Connection with Entry
into Democratic National Committee
Headquarters

1. This memorandum is for the information of the Executive Director/Comptroller.

2. Attached are pertinent traces on three individuals arrested in connection with the entry into the Democratic National Convention headquarters. The first individual, Mr. Frank Anthony Sturgis, has never had a contractual relationship with the Agency. The second person, Mr. Bernard L. Barker, worked with the Agency from mid-1959 and was terminated as an agent on 31 July 1966. Mr. Eugenio Rolando Martinez Careaga is currently under a \$100 monthly retainer fee as an informant for the Miami Station.

3. We are in possession of the three 201 files and continue to study them for additional details. We have called for pertinent operational files from

MEMORANDUM

Frank Anthony Sturgis:-

Mr. Sturgis was born 9 December 1924 in Norfolk, Virginia. He has the following aliases: Frank Fiorini, Fred Frank Fiorini, Fred Attile, Frank Campbell, Frank Attila, and Frank Bonelli. He was honorably discharged from the following services: U.S. Marine Corps in which he served from 1942-45; USNR from 1947 to 1948, U.S. Army 1948 to 1949. According to an FBI report he was arrested in Cuba by Cuban authorities in July 1958 as courier from the U.S. for Cuban rebels. In 1959 he was Captain in the Cuban Army and a government inspector of gambling at the Tropicana Night Club in Havana. He became disillusioned with Castro and returned to the U.S. He was afforded a special hearing by the INS Miami in February 1960 regarding possible deportation on the basis that he voluntarily expatriated himself through service in the Cuban Armed Forces subsequent to January 1959. It was restored 14 months later. In May 1960 he was involved with a group of Cubans in Miami who were to participate in an invasion of Cuba. In December 1960 an FBI informant who lived with Sturgis at that time said Sturgis claimed he was working with and being sponsored by the Agency for some future military action against the Government of Cuba. His photo was on the cover of the Washington Post Parade section in 1961 as a soldier of fortune. He described his Caribbean experiences to Jack Anderson of Parade. In 1961 Sturgis headed an organization called the International Anticommunist Brigade which he claimed had 5,000 men. He has been involved with Gerald Patrick Hemming who is head of the Intercontinental Penetration Forces, another anti-Castro group. He flew in an anti-Castro leaflet dropping mission over Camaguey, Cuba in October 1961. \$10,000 for the leaflets reportedly came from Julio Lobo who has been an Agency contact. Mr. Sturgis has never been recruited by the Agency, but has been associated with Mr. Eugenio Rolando MARTINEZ Careaga, an Agency contract agent, since the early 1960's.

In 1968 he resided in NW Miami and was employed as a used car salesman by G.M. Used Cars, Miami. An FBI report dated 4 April 1969 said that Sturgis a well known American mercenary and soldier of fortune had participated in Cuban revolutionary activities for the past ten years, on 1 November 1968 admitted he recruited twelve American adventurers and mercenaries for military activities against Cuba. In September 68 they met in Mexico and set up a military training camp. Later they boarded a boat and about two days later ran aground near Belize, British Honduras.

Bernard L. Barker

Bernard L. Barker is a former Captain in the USAF in World War II and has been actively cooperating with the Agency since 1959 in Havana and Miami. He was a regular contact of the FBI in Cuba when turned over to the CIA in mid-1959. He was used as source of political information in Cuba, evacuated from Cuba in early 1960 and arrived in the Miami area in January 1960. He was hired by Station JMWAVE in April 1960. He was widely known among Cuban exiles as being affiliated with CIA. He was used by Station JMWAVE to report on Cuban exile activities with emphasis concerning impending exile raids against Cuba. He was trained in surveillance techniques and used to make casing reports. At one time he lost his U.S. citizenship as a result of accepting a position with the Cuban Police Department. His U.S. citizenship has been restored. He was terminated as a JMWAVE contact agent on 31 July 1966 to accept employment by the Rauland Corporation, a subsidiary of the Zenith Radio Corp. in Chicago.

Eugenio Rolando MARTINEZ Careaga:

Mr. Martinez is a 49 year old naturalized U.S. citizen of Cuban birth. Educated at the University of Havana, he has a BS degree and two years' additional work in the School of Medicine. Previously married to a Cuban from whom he is divorced, his current wife is U.S. born. From recruitment by Station JMWAVE in January 1961 to 1969 he was involved in maritime operations and served aboard [redacted] vessels as gunner, mate and captain. Upon termination in 1969 of the maritime project to which he was assigned he was retained as an FI collection asset because of his excellent contacts in the exile community. Met by his WH/Miami case officer regularly, the last meeting was on 6 June 1972. The case officer has been unable to contact him since 14 June. In addition to reporting on activities of exile groups he is also involved in investigative work. [redacted]

Mr. Martinez is a real estate partner of Mr. Bernard L. Barker, also implicated in the plot.

A preliminary damage assessment from Station WH/Miami indicates that Mr. Martinez, if he decided to talk, could reveal that he is receiving \$100 a month from Miami Station to report on the activities of Alpha 66 and other exile groups in the Miami area, and that he received \$8,100 per year previously on a full time basis. True names of persons presently involved in [redacted] True name and physical description of the current COS, Miami, and the alias and physical description of the previous and current case officers. Aliases of a host of former case officers dating back to the early 1960's in connection with his maritime activities. In-depth knowledge of Agency maritime
