ASKED THE GUNMAN THE IDENTITY OF THE SUBSTANCE, HE REFUSED TO ANSWER BUT OFFERED TO INJECT SOME OF IT INTO ARM. HE THEN STATED THAT APPROXIMATELY J\$4 MILLION OF THE DRUGS WAS BEING STORED IN WESTMORELAND ON THE PROPERTY OF DUDLEY ((THOMPSON)), AND IN A NURSING HOME IN SEAFORTH, ST.
