2. [redacted] ON 17 MARCH, A KNOWN WPJ GUNMAN INTIMATELY INVOLVED IN THE DRUG TRAFFICKING OPERATION STOPPED BY THE WPJ OFFICES IN KINGSTON. AT THAT TIME, HE HAD IN HIS POSSESSION TWO BAGS OF A WHITE POWDERY SUBSTANCE PRESUMED TO BE COCAINE. HE ALSO HAD IN HIS POSSESSION TWO BOTTLES OF SEVERAL OUNCES EACH OF A MILKY, WHITE LIQUID. [redacted] COMMENT: THIS LIQUID CANNOT BE READILY IDENTIFIED. IT COULD BE HEROIN OR COCAINE, BUT IT IS HIGHLY UNUSUAL TO SEE EITHER SUBSTANCE PREPARED IN LIQUID FORM IN ADVANCE OF ITS ACTUAL USE.) WHEN
