After the war, REISER was delivered to the Franch on an extraditional request. Up to June 1949 he sat in the Cherchemidi jail in Paris, teing de riefed on the Rote Kapelle by the Franch. When he was released, the Jermans in Kalraruhe promptly put him in jail avaim (as MIRSHA personality). When he was re seased in April 195-, he was E med ately nicked up y EEIDL, but with CIC; and the Frielsh (of 1972-6233) also het on the trail, and all eager for the same thing, RSISE's lote Kapelle knowledge.

b. TEISER is now devoting his full time to a recapitulation of all he remembers about he case; several electrate charts have been, propared, and his report, running to a me 150 pages, should be ready in Gotober. REISER and LEIPL feel there is enough durrent operational activity in the mote Kapelle field to warrent OPPSPRING's submitting a cevelog ental project based on it, after the long study has been submitted and studied by OPPSPRING and its imerican supporters. REISER now regrets that he burned his own files on the case in Karleruhe in 1945 and that two additional trunkfulls he sent to Tauberblachofeheim were burned there by PANNITZ.
