COMMENT: ON 16 SEPTEMBER 1979 THE \*BUENOS AIRES HERALD" REPORTED THAT REGINO ADOLFO G O N Z A LE S. HIS WIFE AND THREE SMALL CHILDREN HAD DISAPPEARED. THE WIFE AND CHILDREN WERE TAKEN AWAY FROM THEIR RESIDENCE BY PERSONS CLAIMING TO BE POLICE.)

AGENTS OF THE ARGENTINE FEDERAL PENITENTIARY INTELLIGENCE SERVICE (SIP - SERVICIO DE INFORMACIONES DEL SERVICIO PENITENCIARIO FEDERAL) PICKED UP THE GONZALEZ FAMILY. THE AGENTS ACTED SOLELY ON THE AUTHORITY OF ALCALDE (MARDEN) 8 I L 8 A. FNU, CHIEF OF SIP. THE ARGENTINE COVERNMENT IS FURIOUS WITH SILVA WHO COMMITTED A GRAVE ERROR BY KIDNAPPING THE FAMILY. ESPECIALLY AT THE TIME OF THE INTER-AMERICAN HUMAN RIGHTS

GROUP WHICH IS FNOWN FOR ITS COMPETENCE. IT IS NOT KNOWN
WHY SIP PICKED UP THE GONZALEZ FAMILY NOR WHERE THE FAMILY
IS BEING HELD. MOST OF THE SECURITY SERVICES INVOLVED IN
THE HUNT FOR THE GONZALEZ FAMILY ARE PROBABLY AWARE THAT IT
WAS A GOVERNMENT OPERATION.)
