a. WILLIAMS arrived in Dar-Es-Salaam,
Tanzania on 24 May 1969. On the morning of
26 May 1969 he appeared at the US Embassy
stating his intention to return to the United
States, however, he wanted to know if he would
receive a hostile reception in the United
States; if so, he could make necessary
preparations.

b. WILLIAMS returned to the US Embassy on 10 July 1969 to seek help in transporting Mainland Chinese films to the United States.

c. WILLIAMS left an address where he could be contacted, the same Post Office Box used by William Henry SUTHERLAND, JR., expatriate American negro pacifist. (SUTHERLAND is the Subject of your Washington, D.C., report dated 30 March 1965, Bureau File #97-3552)

d. Mrs. WILLIAMS and her two sons NOT RECORDED recently indicated that they were planning 183 AUG 18 1969 purchase some firarms for a hunting trip.

as of 25 June 1969, WILLIAMS' wife and two sons were expected to leave Dar es Salaam sometime in the middle of July, 1969, presumably for the United States. WILLIAMS himself planned to remain in Tanzania for an additional month, at which time he would travel to London, England, enroute elsewhere (presumably to the United States). WILLIAMS has made arrangements for 2000 copies of his publication The Crusader to be held abroad for his (WILLIAMS) future use in the United States.
