On 21 Jun 54, the following information concerning SUBJECT, a former ace and high-ranking member of the German Air Force during World War II, who, since the war, has immigrated to Argentina and is allegedly employed by the Air Force of that country as an expert on air tactics, was received from Informant 6030, who in turn received it from a Sub-source of unknown reliability:

During his last trip to Germany, RUDL also included two (2) trips to Salzburg, Austria, where he visited old contacts. Last year, RUDL was supposed to be the main speaker at a discussion evening which was slated to be held in Salzburg. This planned meeting aroused much comment from Salzburg citizens and also aroused the interest of the Security Directorate for the Province of Salzburg. The organizer of this discussion evening was the Salzburg lawyer, (Dr.) Josef Gausong, residing at Gaertnerstrasse, Salzburg-Altlhof. Gausong, a close associate of (Dr.) Adolf Erwin, also finances the Austrian distribution of the allegedly Communist oriented neo-Nazi publication "Deutschland Briefe". SUBJECT was in Salzburg on 5 Mar 54, and contacted persons associated with the NL (Nationale Liga-National League). During his stay in Salzburg, SUBJECT resided at the Hotel "Goldener Loewe". RUDL allegedly has in his possession several passports issued under various names, however, these passports all bore RUDL's picture. In Nov 53, a person observed two (2) of these passports which were issued to a "Franz Huber" and "Paul Meier". RUDL's authentic passport was issued by the Argentine government. This passport was stamped with exit-entry visas for Chile, Uruguay, Spain, Egypt, Germany, Austria, and Morocco, for 1953. On 26 Mar 54, RUDL again appeared in Salzburg and spoke to the Aero Club, Salzburg.

On 22 Jul 54, the name files of the Regional Registry, 430th CIC Detachment, Region "B", APO 174, US Army, were examined regarding personalities mentioned in this report, and the following information was revealed:

Hans Ulrich RUDL: Agent Report, 1/25330, Subject: "Deutschland Briefe", dated 13 Feb 52, states that a (fnu) RUDL in Argentina, is associated with this neo-Nazi Communist-oriented publication. (fnu) RUDL is probably identical with the RUDL mentioned in this report. (evaluated C-4)
