Information published in an Argentine newspaper stated that Herr HANS ULRICH RUDEL, Luftwaffe ace and holder of the highest Nazi military decoration, arrived in Dusseldorf from Argentina a few days ago.</p> <p>2. The German news agency, D.P.A., reported on Tuesday, 10 January, that RUDEL had received official approval from Argentina to travel. This report also stated that RUDEL would continue to represent several German firms in Latin America. No reference was made as to where RUDEL plans to take up residence.</p> <p>Comments of Preparing Officer:</p> <p>3. No information available here indicates that RUDEL is representing any German firms. It is possible that if he is a representative of German firms, they would be East German firms.</p>
