- 1. Information was released recently in Argentina which stated that the Investigating Commission in Cordoba had produced interesting details concerning the activities of PERCN's protégé, the former Nazi flying ace, Colonel HANS URLICH RUDEL.
- 2. From information available there are indications that RUDEL entered Argentina under the name of EMALWAYER and signed a contract with I.A.M.E. (Industrias Aeronauticas y Mecanicas del Estado) where he received a large salary but did no work. Information from Cordoba police files indicates that he later resumed his real name.
- 3. This Investigating Commission has supposedly published a series of letters received from German Nazi leaders urging RUDEL to return and take over the leadership of the Nazi movement in Germany. The last letter, according to this information, voices anxiety about RUDEL's services after the 16 June revolution and states "your friends have see you already at the head of the army fighting for Sr. PERCN or in command of the Argentine Air Force."
- 4. The most interesting information produced by this Investigating Commission is believed to be a letter by Sir OS.ALD, MOSLEY, former leader of the British Fascist Party, addressed to ex-general PERCN on 2 January 1955 in which he writes:
 - "Your Excellency, I have the honour to write to you in connection with my friend Colonel H. U. RUDEL to beg you to again have the kindness of sending him to Europe as soon as possible.
 - "Several of us have the impression that his presence in Europe is of the greatest value for the maintenance of the position of Germany and the whole of Europe against the dangers that now threaten.
 - "Confidence can always be had in him to sustain with ability and energy the .true values of civilization, so much furthered by the work dose by Y.E.".
- 5. From a different source it was reported that in approximately March of 1953 Colonel RUDEL attended a gathering of former Nazis in Stuttgart, Germany, where a number of speeches were made by former Nazi officers who were anti-U.S. and generally follow the communist doctrine. Wery good supporter of RUDEL, VON REICHENAL, a brother of the German Field Marchall VON REICHENAL, was one of the principal speakers at this meeting. This contact told reporting officer that VON REICHENAL had worked for the British during the war in India but after the war had joined up with the communist movement. Contact stated that after this speech in Stuttgart no further contact was made with VON REICHENAL and his whereabouts at this time are unknown. Information available seems to indicate that RUDEL is possibly leaving Argentina and going to Russia or to the Eastern Cone of Germany in the near future. Contact stated that RUDEL had made numerous trips to Germany and had been living in a very luxurious fashion during his stay in Argentina. There are indications that RUDEL's activities here in Argentina could possibly have been financed by the communists.

Comments of Preparing Officer:

6. Generally the information is believed to be true as it has been verified by several sources. Colonel RUDEL is not known by members of this office but is reported to be very anti-U.S. Information from Argentine Air Force personnel indicates that RUDEL contributed nothing to the Argentine Air Force and is not liked by a great percentage of Argentine Air Force personnel.

Translation of Article Appearing in "La Razon" on 12 January 1956

ANOTHER NAZI HIERARCH, KURT TANK, WAS PROTECTED BY THE DICTATOR; AS PLANE DESIGNER LIVED IN COUNTRY AND HELD FAISE DUCUMENTS

- 1. Cordoba The investigating Commission made known the following: "Some days ago the provincial investigating commission told of information on irregularities proven in the granting of documents (Passports, identity cards, certificates, etc.) in favor of HANS UIRICO RUMEL, an ex-German ace of the last war and who had been designated by the Neo-Nazi German Movement as the "Fuhrer" to replace ADOLF HITLER. This confirmed what was in a book written by SILVANO SANTANDER while in exile in Manusvideo during the Argentine dictatorship, a twin to that of Germany."
- 2. KIRT TANK is another of the Germans denounced in the mentioned book. Upon the waris end in Europe, the Argentine dictator in keeping with his fraternal leanings towards Hitlerism, Italian Fascism, etc., gave RUDEL and many others a most cordial welcome. This cordiality made a joke of Argentine law. A designer of Focke wulf planes, TANK was placed under contract by 1.A.M.E.
- In the same way as RUDEL, Tank obtained documents in the country under an assumed name. His case has distinct features, perhaps more grotes us than in RUDEL's case. Think appeared before the Cordoba police as an Argentine. He was "FADRO JORGE MATRIE", con of Guillerad and Ann SCHERTZINGER. Country: Argentine. Province: Santa Fe. Town: Rosario" The rest of the data was authentic. On 7 December 1948 this "Argentine citizen" appeared before the Cordoba police and with the pretext the same as RUDEL of a "Visa for driver's registration" gave these facts and asked for the opening of a file. Here you have an "Argentine citizen" not offering probationary Argentine documentation as one would easily believe an enrollment passbook, identity card obtained in another state, birth certificate No. He presented, as is evidenced from the file which was opened without even any authentic copy nor signature. If an official who certified to the strange presentation, a passport issued in benearly, 13 November 1941, bearing Number 2 and the initials T.E.R.M.B.E.P. and whose translation was delivered to the interested person. Where are the translation and the arginal?
- The same considerations which were made in RUDEL's case applied to TANK:
 MATTIES was an unmown personage in the technical-aeronautical circles. The one contracted by 1.A.M.B. was KURT TANK, the world famous plane designer who was sought after by the Allied authorities to determine his part in the fighting and infamous regimen in whose service he was employed.
- 5. As with RUDEL, the file on TANK is fruitful in documents which were given TANK for use in his distinct activities. Thus TANK committed the crime of using false public documents which is prohibited by article 296 of the Penal Code. All this making a joke of Argentine law was aided and abetted by the Argentine dictator and this followers to whom this aspect of fundamental subjection, the ignorance and the civic violation of legal structures, which they imposed upon the country, mattered little. Pure Ayrians these men apocalyptic agents of the most developed technical and dreaded parbarousness known to the world what does it mean to them to violate, with the complacency and complicity of the Argentine tyrant, the juridical ordinances of a country like ours, as far as they were concerned inferior and inhabited by an impure race?
- 6. As in the case of RUDEL, there came a moment in which TANK decided to "retake" his true name. That moment surely is marked by a change in international conditions and a disappearance of the canger for Nazi-German air aces and technicians. With the
