OUR PRIMARY INTEREST IS TO DETERMINE WHETHER ANY NON OFFICIAL PERSONS OR ORGANIZATIONS AVAILED THEMSELVES OF BDC INFORMATION IN DOING PRESS STORIES BASED ON THE SS BACKGROUNDS OF THE ABOVE PERSONS AND, IF SO, THE IDENTITIES OF THE REQUESTORS. SAEVECKE, THROUGH SG OFFICIAL HEINZ LUEBKE, HAS ASKED US TO CHECK ON QUERIES CONCERNING HIM FOR HIS OWN INFORMATION. DEPENDING ON THE REPLY, WE REALIZE THAT IT MAY NOT BE POSSIBLE TO PASS ON TO HIM THE INFORMATION THUS OBTAINED. HOWEVER, THIS CAN BEST BE DETERMINED ONCE THE RESULTS OF THE CHECK ARE AT HAND.

3. THE REQUEST PERTAINING TO WENGER ORIGINATES WITH BONN BASE IT IS LEVIED BECAUSE HE IS AN IMPORTANT KUBARK CONTACT IN THE BFV WHOSE NAZI BACKGROUND MAKES HIM A POTENTIAL TARGET OF DEFAMATION CAMPAIGNS.
