GARRISON SAID NOVEL ADMITTED WORKING WITH THE LATE DAVID

GARRISON PROMISED TO GRANT NOVEL IMMUNITY FROM PROSECUTION
IF OHIO COURTS WILL ORDER HIM TO RETURN TO NEW ORLEANS.

FERRIE, A ONE-TIME AIRLINE PILOT WHO DIED LAST FEBRUARY
FIVE DAYS AFTER THE GARRISON INVESTIGATION BECAME PUBLIC,
PARTICIPATED IN OPERATIONS DURING THE CIA-BACKED BAY OF PIGS
INVASION OF CUBA IN 1961.

GARRISON SAID HIS OFFICE "HAS SUCCEEDED IN IDENTIFYING THE
ASSASSINATION OF PRESIDENT KENNEDY AS AN OPERATION CONDUCTED
BY ELEMENTS OF THE CIA."

FERRIE WAS AMONG FOUR PERSONS WHOM GARRISON HAS CHARGED
DIRECTLY WITH PARTICIPATING IN A PLOT TO KILL THE PRESIDENT.
