FORMER PRESIDENT ARTURO ((FRONDIZI)) WAS SERVING IN THE
FIRST PART OF AUGUST 1983 AS AN INTERMEDIARY BETWEEN
LIEUTENANT GENERAL (LTG) CRISTINO ((NICOLAIDES)), COMMANDER
OF THE ARMY AND A MEMBER OF THE RULING JUNTA, AND MARIO
((FERMENICH)), THE LEADER OF THE MONTONERO GUERRILLA
MOVEMENT. FRONDIZI'S EFFORTS INVOLVED TRYING TO PERSUADE
FERMENICH TO REACH AN AGREEMENT UNDER WHICH THE GOVERNMENT
WOULD PERMIT THE MONTONERO MOVEMENT TO OPERATE AS A
LEGITIMATE, OPEN POLITICAL ORGANIZATION IN EXCHANGE FOR THE
MONTONEROS' NOT RETURNING TO VIOLENCE.

2. UNDER THE AGREEMENT AS VISUALIZED BY NICOLAIDES,
THE GOVERNMENT WOULD FREE 300 IMPRISONED MONTONEROS AND
PERMIT THEM TO REJOIN THE POLITICAL LIFE OF THE COUNTRY.
THE GOVERNMENT WOULD ALSO PERMIT MONTONEROS LIVING IN
EXILE TO RETURN TO ARGENTINA. ([redacted] COMMENT: [redacted]

() NICOLAIDES HAS SUGGESTED THE ARRANGEMENT WITH THE MONTONEROS IN ORDER TO GAIN LEFTIST SUPPORT FOR A PROPOSED AMNESTY LAW THAT THE ARMED FORCES HAVE HAD UNDER CONSIDERATION AND HAVE DEBATED OVER THE PAST WEEKS, A LAW WHICH WOULD BENEFIT INDIVIDUALS WHO FOUGHT AGAINST THE MONTONEROS AND OTHER LEFTISTS DURING THE ANTISUBVERSIVE CAMPAIGN OF THE 1970'S. A PRECEDENT EXISTS FOR THE ARRANGEMENT SUGGESTED BY NICOLAIDES IN A SIMILAR AGREEMENT REACHED BY THE ADMINISTRATION OF HECTOR ((CAMPORA)) AND THE LEFT IN 1973.)

5. () COMMENT: ALTHOUGH THIS REPDTRORT SEEMS SOMEWHAT FARFETCHED IN LIGHT OF THE ARMY'S STRONG ANTI-MONTONERO FEELINGS, IT MAY BE THAT NICOLAIDES IS TRYING TO DEVELOP A JUSTIFICATION FOR RELEASING THE PRISONERS AS MANY IN THE ARMED FORCES ARE RELUCTANT TO HAVE THEM ON THE STREET.)
