REPUBLIC. SASAGAWA IS KNOWN TO USE MOST, IF NOT ALL, OF THESE ORGANIZATIONS AS FRONT COMPANIES TO ADVANCE HIS OWN "IMAGE CLEANING" ACTIVITIES AS WELL AS TO SHIFT FINANCES FOR A VARIETY OF PURPOSES, BOTH ABOVE AND BELOW BOARD. 4. IN THE PAST TWENTY YEARS, SASAGAWA HAS ATTEMPTED TO CLEAN UP HIS IMAGE BY CONTRIBUTING LARGE SUMS OF MONEY TO A VARIETY OF INTERNATIONAL ORGANIZATIONS, PROGRAMS, CHARITIES, UNITED NATIONS PROJECTS, AND PROJECTS OF INTERNATIONAL FIGURES. IN ALL HIS ENDEAVORS, SASAGAWA ATTEMPTS TO MAKE A PRODUCTION OF THE GIFT GIVING AND HIS GENEROUS GIFTS. TWO RECENT EXAMPLES OF THIS TYPE OF ACTIVITY WAS WHEN A BUST OF SASAGAWA WAS PLACED IN THE WORLD HEALTH ORGANIZATION IN GENEVA, AFTER HE CONTRIBUTED 3 MILLION USD TO UN AGENCIES, AND WHEN HE RECEIVED MUCH ACCOLADE AND PRESS FOR CONTRIBUTING TO THE AFGHAN REFUGEE CAUSE. IT IS WIDELY KNOWN THAT THE FUNDS SASAGAWA GIVES TO THESE PROJECTS ARE MOSTLY, IF NOT COMPLETELY, THE CAPITAL RAISED THROUGH HIS LEGAL (ALBEIT FIXED) GAMBLING ENTERPRISES WHICH MUST, BY JAPANESE TAX LAW, BE CONTRIBUTED TO CHARITABLE CAUSES.
