1. AFTER DISCUSSING WITH E A, C A SAW SCHOLZ 29 AUG.
 AFTER ADVISE (A) FINAL DRAFT PROBABLY WILL BE READY THIS WEEKEND
 AND HE WILL SHOW IT TO US THEN, (B) CONTENTS EMPHASIZE EAST GERMAN
 MEASURES SINCE 13 AUG, EXPOSE WHAT INTERNATIONAL AGREEMENTS BEEN
 BROKEN THEREBY, CITE REFUGEE STATISTICS AND DESCRIBE CONDITIONS WHICH
 LED TO MASSIVE FLIGHT MOVEMENT, (C) HAS BROACHED WITH FEDERAL
 PRESS OFFICE, DGB, AND SPD, ALL OF WHICH LIKELY PROVIDE SOME SUPPORT

TO FOREIGN AUDIENCES OF ESSENCE.

2. TOLD SCHOLZ KUBARK HAS AUTHORIZED DM 20,000 TO SUBSIDIZE
FOREIGN LANGUAGE EDITIONS AND SUGGESTED AREAS OF SPECIAL IMPORTANCE.
HE MOST PLEASED, STATING THAT THIS WILL ENABLE HIM USE AIRMAIL
RATHER THAN MUCH TOO SLOW SURFACE SHIPMENTS. SAID HAS LARGE NUMBER
ADDRESSEES FROM PREVIOUS OVERSEAS TRIPS, WILL ALSO ASK LCPAGAN-1
